Outline	The Graduate School of Engineering Science at the University of Osaka invites applications for an Assistant Professor position in the Biological Information Engineering Group. This position is open to individuals interested in conducting interdisciplinary research grounded in fields such as bioengineering and health informatics. The successful candidate will engage in research aimed at the development of digital biomarkers that objectively evaluate and detect physical and mental health conditions, including disease and pre-disease states, based on biological signals. This position also involves pursuing research aimed at elucidating the biological mechanisms that underline these processes. We seek an individual with a flexible mindset who can make significant contributions to advancing research in this field. In addition to research activities, the appointed candidate will be responsible for teaching in university-wide common education, as well as in undergraduate and graduate programs.
